

RESPONSE

on the monograph of S. Dombrovska, A. Pomazy-Ponomarenko, S. Poroky, A. Urbanek on the topic "Security policy of Ukraine in the conditions of European integration"

Guaranteeing the security system is one of the fundamental tasks of the state, which belongs to the political and legal block of management tasks. Its solution for Ukraine requires a systemic solution in the medium and long term, as well as the formation of a positive image of our state in the international arena. After all, it is currently associated with a war country, a disaster country, but by no means a safe leader in Eastern Europe.

The implementation of the security policy takes place throughout the vertical of state power and should provide for the protection of citizens' rights. In recent years, there has been a resurgence of interest within the fundamental science of public management and administration in the areas of implementation of state policy in the security sphere of Ukraine, in particular, from the standpoint of determining mechanisms for the protection of human rights in armed, military, and other conflicts. In order to solve the above-mentioned issues, it is necessary to thoroughly develop conceptual principles for the development of Ukraine's security policy, which provides for a timely response to a decrease in the level of its security due to full-scale aggression by the Russian Federation. The peer-reviewed monograph of S. Dombrovska, A. Pomazy-Ponomarenko, S. Poroka, and A. Urbanek is dedicated to the study of these aspects, which testifies to the relevance of the topic of the monographic research conducted by the authors.

The reviewed monograph systematizes scientific and methodological developments related to determining the place of security in the institutional system of public administration. In addition, the monograph provides a description of the organizational and legal mechanisms of security policy, taking into account the provisions of other related sciences, in particular law, political science, etc. This made it possible to clearly delineate the object and subject of research, applying the methods of analysis and synthesis, induction and deduction, historical and legal analysis, modeling, etc.

It is worth noting that the authors of the monograph rightly justify the need to build Ukraine's foreign policy reputation as a projected capable state, a regional security leader in Eastern Europe. In this context, directions for the development of Ukraine's security policy in the context of European integration are determined (Chapter 4). Within these directions, the informational, analytical and other supporting role of the institutional security

policy toolkit has been specified, as well as the specifics of Ukraine's international cooperation with partner states in the field of collective security.

In continuation, we note that Andrzej Urbanek, a Polish colleague and specialist in issues of collective security, vice-rector for scientific work of the Pomeranian Academy in Slupsk, took part in the monographic study. His experience made it possible to raise the scientific level of the reviewed monograph from the standpoint of determining the European practice of security policy formation, as well as promising ways of taking it (practice) into account on domestic grounds.

Therefore, the scientific results obtained during the research are reliable and well-argued. They are based on a detailed analysis of theoretical research and practical experience. The tables given in the monograph are meaningful, have the necessary explanations and clarifications. On the basis of the above, we believe that the peer-reviewed monograph by S. Dombrovska, A. Pomazy-Ponomarenko, S. Poroka, and A. Urbanek can be recommended for further consideration by the academic council of a higher education institution for submission to a competition for the best scientific, scientific and technical and career guidance products in the apparatus of the Ministry of Internal Affairs, territorial bodies, establishments, institutions and enterprises belonging to the sphere of management of the Ministry of Internal Affairs of Ukraine.
